Provide technical assistance to individuals, groups and units of government in Lorain County for the management of natural resources including soil, water, forest and other related issues.

Technical Programs

- On-site technical assistance to farmers & landowners for a variety of soil, water, & related natural resource topics such as drainage, erosion control, water quality improvement, forestry, wildlife management, etc...
- Planning and survey design for conservation practices such as grassed waterways, filter strips, wetlands, erosion control structures, animal waster systems, composting facilities, high tunnel structures, fertilizer containment & chemical storage facilities (these practices are generally done thru NRCS with SWCD assistance)
